## STEP ONE: APPLICATION

**Contact Holly Drexler** at Chance Recovery (located at 456 SW Monroe Ave, Suite 108, Corvallis, OR). Discuss eligibility requirements and submit an application if those requirements are met. (The application process can take as long as 6 weeks to complete based on performance)

## STEP TWO: FIRST INTERVIEW

We meet and hear your story, explain the program and ask questions regarding your application. At this time, you also grant permission for a background check to be conducted.

(You will be notified via text or email if you are being invited to continue the process of acceptance. This usually happens within a week after this interview is completed)

# SPARROW MINISTRIES APPLICATION PROCESS

## STEP THREE: ACCEPTANCE PROCESS

**Begin attending mentoring sessions & group meetings:**

Things you will do:

- Be open about your finances. Make a budget and stick to it during that week in your spending.
- Show pay stubs & track your spending by keeping all of your receipts and bringing them to finance mentoring meetings.
- Attend Peer Support meetings to work toward goals
- Attend Counseling sessions to work on emotional health
- Attend Group Meetings to discuss various life topics on relational and emotional health (Thurs. 6:15-8:15 pm)
- Attending any meeting late or unprepared (without homework done) will delay your progress through the application process.

### **Background Check:**

Required to advance in the application process

### **Drug Testing:**

Complete random drug tests administered by Holly or Kevin at the Chance Recovery Office during application process.

**Readiness for the program will be assessed after one month of successful program participation**

## STEP FOUR: SECOND INTERVIEW

Upon successful completion of one month of program participation, you will be invited to a **second interview**. At this interview, we will discuss how the trial program sessions went and assess your readiness for the program long term. If approved, you will receive permission to move on to the final steps of the application process.

#### MONDAY MENTORING (4-6 PM)

Mentoring on Mondays include:

**Peer support meetings** that help you  
work toward physical goals

**Counseling sessions** that help you work  
toward better mental and emotional  
health

**Finance coaching sessions** to help you  
advance toward a healthier financial  
future.

#### THURSDAY GROUP MTGS (MEAL: 5:30 PM/MTG: 6:15-8:15 PM)

**Thursday group meetings** include a  
meal together monthly (at 5:30 pm) as  
well as a meeting from 6:15-8:15 pm every  
week.

These meetings focus on emotional  
healing as well as providing you with the  
needed skills to develop better  
relationships with your families, children,  
workplace and God.

There are various topics covered in these  
meetings dependent on the specific  
needs of our families at the time.

# SPARROW MINISTRIES

## PROGRAM

### *General Information*

#### BASIC PROGRAM REQUIREMENTS

Monthly Program Fee: Pay \$300/\$350 per month depending  
on the unit available when you participate.

Regular Meeting Attendance: Punctual meeting attendance  
and homework completion is a fundamental requirement  
for success in this program.

Regular Random Drug Testing: Random drug tests will be  
administered throughout the duration of your stay in this  
program. Sparrow is a drug and alcohol free program.

Furnished Living Space Provided: Program participants may  
bring personal belongings for basic needs. Larger items  
need to be stored off site until program completion, and  
pets are not allowed.

Follow Rules & Care for Living Space: Following Sparrow  
rules, caring for your living space is essential to your success  
and ability to stay in the program the maximum time (1 yr).

#### PROGRAM INCENTIVES

Sparrow offers various incentives to encourage you on your  
journey towards wholeness and a better life for you and your  
family!

**GAS VOUCHERS:** Attending meetings on time with  
homework done earns program participants vouchers to  
purchase gas gift cards. (1 voucher can be earned per  
meeting/3 vouchers earn a \$25 gas card.)

**HOME CREDIT:** For every month you invest in our program  
(by faithful participation and payment of the program fee),  
Sparrow will set aside \$100 toward your new housing upon  
graduation from our program.

12 months of faithful payment & participation = \$1200 gift  
credit toward your new home when you graduate.

You must finish our program successfully & move into a  
home of your own (rent or buy) to access this gift credit.

Moving into another program does not qualify you. Payment  
will be given in the form of a gift credit toward house related  
expenses, not cash.

#### CHRISTIAN PROGRAM

Sparrow is a Christian program and as such, will require you  
to participate in biblical discussions and spiritual content.
